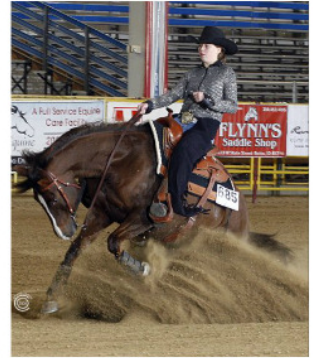

Stallion Service and Shipped Semen Agreement



This document constitutes an agreement for breeding the mare specified below to the Quarter Horse stallion **Nu Steps To Cash, AQHA #4763938**, for the 2017 breeding season, using AI and/or fresh cooled semen.

The parties in this agreement are:

1. The stallion's owners: Michael and Catherine Frank of BAF Performance Horses.

These parties agree to the following terms and conditions:

2017 Breeding Fee:

Breeding fee for 2017 is \$1,000, which includes the \$400 booking/chute fee.

On-site mare care:

We offer on-site mare care at \$12/day. The on-site mares are kept in a dry paddock, with water and fed grass/alfalfa mixed hay, twice a day. We use the services of Dr. Jed McKinlay of McKinlay and Peters Equine Hospital for AI services.

We do offer onsite mare care service and the transport of your mare once she comes into heat from our farm to Dr. Jed McKinlay's Colbert, WA office. The mares generally stay at MPEH 6-7 days.

For pricing, information and to set up an account with MPEH prior to breeding please contact them @ 509-238-4959 or email debbie@mpevh.com.

Also, we do offer the service of picking the mare up and bringing her back to our farm after AI services. The mare can stay until you are ready to pick her up or until she is ready for 14 day pregnancy check. If you are bringing your mare here from out of town, we recommend she stays through the 30 day pregnancy check (at which time the foal's heart beat is visible) before she goes home.

Shipped semen available @ \$350 per shipment *see info below

Shipped semen:

To ensure professional service we use McKinlay and Peters Equine Hospital to collect our stallion. Visit their website @ www.mckinlaypetersequine.com. **Shipped semen fee is \$350, this includes collection and shipping.** Semen will be shipped via Fed Ex. Semen collection days are Monday, Wednesday and Friday. If other days are needed we are always happy to assist, whenever possible. Requests for cooled semen, if possible, should be made at least 48 hours prior to, the anticipated shipping day. Requests should be made to Cathy Frank at 509-868-1627. **We ask that you confirm or if needed, cancel the shipment by 12:00 pm PST the day before semen is to be collected and shipped.** Requests will be honored on a first come first serve basis. The mare owner agrees to use all cooled semen provided by this agreement for the mare named in this contract and no other. The mare owner understands that semen may not always be available when desired. For information and to set up an account with MPEH prior to breeding please contact them @ 509-238-4959 or email debbie@mpevh.com.

Rebreed privileges:

BAF Performance Horses agrees to diligently try to settle the Owner's mare. The Mare Owner agrees to give BAF Performance Horses ample time to settle the mare. If for any reason the mare does not settle rebreed privileges will be available. **When using the rebreed privileges, there is a farm fee of \$200.** Rebreed privileges are for the year following the date of the original contract. If the Mare Owner fails to return the following year, then any and all fees paid shall be forfeited, the right to rebreed is canceled and BAF Performance Horses is released from all obligations of this contract. If special circumstances arise and the mare owner is unable to return their mare the following year for a rebreed please, contact BAF Performance Horses and discuss extending the rebreed season.

Live Foal Guarantee (LFG):

The Live Foal Guarantee shall pertain to mares that are pronounced **Safe in foal by a veterinarian within 90 days** after the last breeding date. A live foal is defined as one that will stand and nurse without assistance. If the foal dies at birth or has to be put down for any reason the Mare owner agrees to furnish BAF Performance Horses, within 7 days, a veterinary's note stating the occurrence and rebreed privileges will be available.

The **LFG** in this contract is for the mare and owner(s) listed and is non-transferable. If you, the mare owner wishes to sell your mare and would like the LFG to be transferred to the new owner please contact us prior to the sale. In the event that BAF Performance Horses agrees to transfer the **LFG** rights written in terms of this contract, to a new owner, then the new owner must agree to submit a new signed contract to BAF Performance Horses. If the mare dies or becomes unfit to breed, the Mare Owner may substitute a mare. Rebreed privileges will be available.

Breeder's certificate:

A Breeder's Certificate will be issued for the foal when the mare has produced a live foal from this breeding and all expenses due BAF Performance Horses have been paid in full. Mare Owner is responsible to contact BAF Performance Horses and notify them of the foal's arrival.

Accidents, death or injuries:

If the above named stallion dies or becomes unfit for service for any reason, then this contract will be null and void and both parties are relieved of any further obligation. Any monies paid by the Mare Owner toward the Breeding Fee, not to include fees paid towards semen already shipped, shall be refunded to the Mare Owner, if the mare is not settled.

If for any reason the mare does not settle, even after the use of rebreed privileges, the Mare Owner will hold BAF Performance Horses harmless and the breeding fee will be refunded with the exception of the \$200 farm fee.

5 Panel Testing:

Nu Steps To Cash has been 5 panel tested and his results are:
HYPP N/N Herda N/N Gbed N/Gb PSSM 1 N/N MH N/N
We recommend the 5 panel testing for all mares.
If you have any questions about 5 panel testing please ask.
